Leadership PROGRAMS

Leadership Beaufort

Established in 1985, Leadership Beaufort is a 9-month, cohort-based community immersion program. Selected participants get a holistic view of the region and learn how to make a difference.

Leadership Alumni

Program graduates continue community engagement and keep connections strong through an active alumni group.

Lowcountry Young Professionals

Recruiting and retaining prime workforce aged citizens is the one of the larger initiatives of our region. While businesses do their part, the Chamber hosts a Young Professionals network to connect, unite, and develop the area’s future leaders. Activities include monthly socials, professional development programs, and a signature event.



COMMITTEES *and* COUNCILS

Finance Committee

Provides oversight of resources and works to ensure the Chamber is financially and operationally equipped to accomplish its mission. Comprised of sitting Board Members.

Public Policy Committee

Monitors local, state and federal public policy issues germane to the Chamber, and recommends new legislative priorities and positions to the Board of Directors. Members are appointed by the Board Chair.

Nominating Committee

Oversees Board tenure and recruit new members to the Board of Directors, reflecting a diverse group to represent the region's business environment. Comprised of sitting Board Members.

Community Advancement Council

Serves as a member forum to discuss emerging issues relevant to promoting the region's economic prosperity. Open to all Chamber investors.

Lowcountry Land Council

Promotes best practice in sustainable development, reviews public policies that have implications for land development, dialogs with local officials, makes recommendations to the Chamber's Public Policy Committee for consideration. Members are an interdisciplinary group of development professionals.

Chamber Ambassadors

Ambassadors actively promote membership in the Chamber, facilitate networking among investors and encourage meaningful participation and involvement in Chamber programs. New Ambassadors are welcomed each January.

MILITARY

The Beaufort region is home to three military installations - Marine Corps Air Station Beaufort, Marine Corps Recruit Depot Parris Island, and Naval Hospital Beaufort - which house multiple training and force readiness missions that are vital to national defense. Combined, the installations generate \$2.5 billion annually in economic activity and support nearly 20,000 people.

The Military Enhancement Committee (MEC) of Beaufort County works with community and government partners to sustain and enhance the quality and value of the military installations of Beaufort County. The MEC is comprised of nine voting members appointed by public and private entities from around the region.

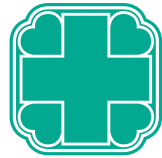
